JUDGING CRITERIA:

Entries must be made primarily of gingerbread and will be judged in four categories:

Overall Appearance • Originality/Creativity • Difficulty • Precision

All rulings by the judges are independent and final, and are in no way are influenced by The Original Benjamin's.

MATERIALS:

Except for the base, entries must be made primarily of gingerbread and composed completely of edible products. Edible materials are not limited to sweets. No artificial display materials, such as Styrofoam, are to be used in the construction of the house. Candies must be unwrapped and free of any Inedible materials (such as lolly pop sticks). NO Gingerbread kit Houses will be accepted except in the Children's Division (ages 4-7) only.

WHO QUALIFIES:

The competition is open to everyone.

DELIVERY:

Entry forms must be received either via FAX (843) 449-0056 or mail by **Friday, November 21st, 2025 by 5:00 PM**. Completed entries must be delivered to The Original Benjamin's Restaurant on **Saturday, November 22nd, 2025 between 10:00 AM and 12:00 Noon** with competitors name labeled underneath the base. You will also need to fill out the explanation form of products used in your design and brief description of the assembly of your entry (Bring this form with you when you deliver your house). NO Gingerbread Kit Houses will be accepted except in the Children's Division (ages 4-7) only. Judging will begin at 6:00 PM. Entries that are not pre-registered will not be accepted. Entries will be on display at The Original Benjamin's throughout the holiday season, which ends January 1st, 2026. (Houses may be picked up on January 2nd, 2026. Houses not picked up will be discarded after that date.) **ONLY A LIMITED NUMBER OF ENTRIES WILL BE ACCEPTED.** Entry form must be received by Friday, November 21st, 2025 at The Original Benjamin's. The Original Benjamin's reserves the right to refuse any entry it deems inappropriate for display. **PLEASE RETAIN THIS SHEET FOR REFERENCE ENTRY.**
